A \$250 per-party, non-refundable Mediation Case Management Administrative Fee, is required to initiate REMS' administration of the Mediation and appointment of the Mediator.

A joint \$2,500, refundable (in certain circumstances only), Mediation Case Management Administrative Fee, is required to reserve a Mediation date.

A Mediation Retainer (amount depending on whether a full or half day Mediation is being scheduled) is due ten (10) days prior to the scheduled Mediation Date, at the time of submission of any Confidential Mediation Statements (if any).
